

<b>DATA CONTROLLER:</b>	The data controller is <b>LUNGOMARE SOC. COOP. IMP. SOC. <b>TYPE OF DATA PROCESSED:</b>	The data processed by the Data Controller, collected directly from the data subject, are those necessary to achieve the purposes set out in the following point. By way of non-exhaustive example they are: <ul style="list-style-type: none"> <li>• First name, Surname</li> <li>• E-mail address</li> <li>• Telephone number</li> <li>• Tax code</li> <li>• IP address and browsing data</li> <li>• Additional data entered in the contact form</li> </ul>
<b>SOURCE OF PERSONAL DATA:</b>	The personal data that <b>the Controller</b> will hold are collected directly from the person concerned when filling in this form.
<b>PURPOSE OF DATA PROCESSING AND LEGAL BASIS:</b>	The processing of your data, collected and stored in connection with the completion of this form, has as its legal basis your consent and is carried out for the following purposes: <ul style="list-style-type: none"> <li>• Responding to any requests for information regarding the services we offer.</li> <li>• Sending information/newsletters about our services by e-mail or messaging services (sms, whatsapp etc.) such as, for example, reminders about the start of a course, postponement of a meeting due to weather, information about the start of a new course etc.</li> </ul>
<b>COMPULSORY OR NON-COMPULSORY PROVISION OF DATA:</b>	We inform you that the provision of data is optional, and that failure to provide data will result in the form NOT being sent.
<b>RECIPIENTS OF THE DATA:</b>	Within the limits pertinent to the processing purposes indicated, your data may be communicated to partners, consultancy companies, private companies, appointed as Data Processors by the Data Controller. Your data will not be disseminated in any way.
<b>DATA TRANSFER:</b>	The Controller does not transfer data outside the borders of the European Community
<b>RETENTION PERIOD:</b>	The data collected will be stored until your consent is revoked or for a period of approximately 60 months.
<b>RIGHTS OF THE DATA SUBJECT:</b>	As a Data Subject, you always have the right to request from the Controller: <ul style="list-style-type: none"> <li>• Access to your data and information</li> <li>• The rectification and deletion ('right to be forgotten') of data</li> <li>• Limitation of processing or the possibility to object to processing</li> <li>• Withdrawal of consent given</li> </ul> <p>For the enforcement of your rights, you may contact the Data Controller directly. <b>MODALITIES OF DATA PROCESSING:</b>	The data you provide will be subject to processing operations using manual, computerised or telematic tools, in any case in compliance with the GDPR and the confidentiality obligations that inspire the Controller's activity. The data will be processed by computerised means, on paper and on any other suitable support, in compliance with the appropriate security measures pursuant to Article 5(1)(F) of the GDPR.
